Introduced by: The President of the Council at the request of the County Executive

A RESOLUTION TO AMEND THE FISCAL YEARS 2018 – 2022 CAPITAL IMPROVEMENT PROGRAM AND CAPITAL BUDGET TO INCLUDE GRANT FUNDING, IN THE AMOUNT OF NINETY-NINE THOUSAND DOLLARS (\$99,000), FOR THE CEDAR HILL PARK MARINA RESTORATION PROJECT, IN FISCAL YEAR 2018, TO REPLACE FAILING BULKHEAD, PILINGS AND FINGER PIERS AT THE CEDAR HILL MARINA.

WHEREAS, pursuant to Section 704 of the Wicomico County Charter titled "Capital Program and Budget," the County Council may, upon recommendation of the County Executive, after public hearing, amend the adopted Capital Program and Budget; and

WHEREAS, the Capital Program and Budget for Fiscal Years 2018 – 2022, adopted by Resolution No. 14-2017 on February 7, 2017, did not include grant funding in fiscal year 2018 for the Cedar Hill Park Marina Restoration Project; and

WHEREAS, the Department of Recreation, Parks and Tourism is requesting an amendment to the Capital Improvement Program and Capital Budget to include grant funding, in the amount of Ninety-Nine Thousand Dollars (\$99,000), in fiscal year 2018, to replace failing bulkhead, pilings and finger piers at the Cedar Hill Marina; and

WHEREAS, a public hearing was held on February 20, 2018, to include said grant funding in fiscal year 2018 for the Cedar Hill Marina project in the Capital Program and Budget for fiscal years 2018-2022.


NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland, that the Fiscal Years 2018 - 2022 Capital Program and Budget is hereby approved as amended to include grant funding, in the amount of Ninety-Nine Thousand Dollars (\$99,000) for the Cedar Hill Marina Restoration Project in fiscal year 2018.
