**Resolution No. 29-2018**

Introduced by: The President of the Council at the request of the County Executive

A RESOLUTION MAKING A SUPPLEMENTAL APPROPRIATION FROM CONTINGENCY TO THE TRI-COUNTY COUNCIL FOR THE LOWER EASTERN SHORE, IN THE AMOUNT OF FIFTY-TWO THOUSAND THREE HUNDRED FORTY-FIVE DOLLARS (\$52,345), FOR THE PHASE III CONSTRUCTION PROJECT.

WHEREAS, Section 709 of the Wicomico County Charter authorizes and empowers the Wicomico County Council, upon the request of the County Executive, to make supplementary appropriations from unexpended and unencumbered funds set aside for contingencies; and

WHEREAS, the Maryland Transit Administration (MTA) Grant for the Phase III construction project was awarded over five years ago; and

WHEREAS, construction costs have increased over five years and MTA has determined they cannot provide additional construction capital funds to the Phase III Construction project; and

WHEREAS, to help with the funding shortfall, MTA converted Capital Equipment grant funding to a Construction Grant in FY18; and

WHEREAS, additional funding is still needed to help offset the funding shortages for the Phase III Construction project; and

WHEREAS, Tri-County Council has requested funding in the amount of Fifty-Two Thousand, Three Hundred Forty-Five Dollars (\$52,345) from the County to assist with the funding shortfall for the Phase III Construction Project; and

WHEREAS, the Director of Finance has certified that the appropriation to be transferred is not encumbered and funds are available for transfer.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland that the following supplementary appropriation of funds is authorized and approved:
