### Resolution No. 77-2018 (SM)

Introduced by: The President of the Council at the request of the County Executive

A RESOLUTION AUTHORIZING J.G. PARKS & SON, INC. AS A SOLE SOURCE VENDOR FOR THE PURCHASE OF PARTS, SERVICE CALLS AND PREVENTATIVE MAINTENANCE ON WESTERN STAR TRUCKS AND TO WAIVE THE FORMAL COMPETITIVE BIDDING PROCESS FOR THE PURCHASE OF SAID PARTS, SERVICE CALLS AND PREVENTATIVE MAINTENANCE DURING FISCAL YEAR 2019.

WHEREAS, pursuant to Charter Section 802 (A), any single purchase or contract involving an expenditure of more than Five Thousand Dollars (\$5,000) or such amount as may be set by legislative act of the county shall be made from or let by sealed bids or proposals; and

WHEREAS, on April 4, 2017, the County Council approved Legislative Bill 2017-04 enacting a new Purchasing Manual and setting the amount for competitive bidding to Twenty-Five Thousand Dollars (\$25,000); and

WHEREAS, pursuant to Charter Section 802 (B), the County Council may waive the formal competitive bidding process for any single purchase or contract if the waiver will best serve the interest of the County; and

WHEREAS, the Department of Public Works desires to purchase parts, service calls and preventative maintenance for Western Star Trucks that are crucial to the department's operations; and

WHEREAS, the County Executive, upon the recommendation from the Purchasing Agent, has determined that it is impractical to competitively bid the purchase of these parts, service calls and preventative maintenance as J.G. Parks & Son, Inc. is the only local authorized dealer for sales and service for Western Star Trucks; and

WHEREAS, the County Council has determined that the purchase of parts and repair service for Western Star Trucks is in the best interest of the County.


NOW, THEREFORE, BE IT RESOLVED by the County Council of Wicomico County, Maryland as follows:

1. J.G. Parks & Son, Inc. is authorized as a sole source vendor for the purchase of parts, service calls and preventative maintenance for Western Star Trucks during Fiscal Year 2019.
2. The formal competitive bidding requirement is hereby waived for the purchase of parts, service calls and preventative maintenance for Western Star Trucks during Fiscal Year 2019.
3. To ensure a transparent environment that is open and fair, the approval of J.G. Parks & Son, Inc. as a sole source vendor and the waiver for competitive bidding shall be valid only for a period of one year, commencing July 1, 2018 and ending June 30, 2019.
