### Resolution No. 99-2018

Introduced by: The President of the Council and the County Executive

A RESOLUTION TO AMEND THE FISCAL YEARS 2019 • 2023 CAPITAL IMPROVEMENT PROGRAM AND CAPITAL BUDGET FOR THE RECREATION, PARKS & TOURISM, ARTHUR W. PERDUE STADIUM MODERNIZATION PROJECT, TO INCREASE THE STATE OF MARYLAND GRANT FUNDING FROM FOUR HUNDRED EIGHTY THOUSAND DOLLARS (\$480,000) TO FIVE HUNDRED EIGHTY THOUSAND DOLLARS (\$580,000).

WHEREAS, pursuant to Section 704 of the Wicomico County Charter, titled "Capital program and budget," the County Council may, upon the recommendation of the County Executive, after public hearing amend the adopted Capital Budget; and

WHEREAS, the Capital Improvement Program for fiscal years 2019 through 2023, adopted by Resolution No. 18-2018 on February 20, 2018, projected the grant funding from the State of Maryland for the Arthur W. Perdue Stadium Modernization project to be Four Hundred Eighty Thousand Dollars (\$480,000); and

WHEREAS, the Department of Recreation, Parks & Tourism received an unanticipated additional One Hundred Thousand Dollars (\$100,000) from the State of Maryland for Arthur W. Perdue Stadium Improvements; and

WHEREAS, the Department of Recreation, Parks & Tourism desires to amend the Capital Improvement Program for Fiscal Years 2019-2023 to include the additional grant funding from the State of Maryland; and


WHEREAS, on September 4, 2018, a public hearing was held to amend the fiscal years 2019 through 2023 Capital Improvement Program and Capital Budget to increase the State of Maryland Grant Funding for the Arthur W. Perdue Stadium Modernization Project from Four Hundred Eighty Thousand Dollars (\$480,000) to Five Hundred Eighty Thousand Dollars (\$580,000).

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland that the Fiscal Years 2019 through 2023 Capital Improvement Program and Capital Budget is hereby approved as amended to increase the State of Maryland grant funding for Arthur W. Perdue Stadium Modernization Project from Four Hundred Eighty Thousand Dollars (\$480,000) to Five Hundred Eighty Thousand Dollars (\$580,000).
