A RESOLUTION TO AMEND THE FISCAL YEARS 2019 – 2023 CAPITAL IMPROVEMENT PROGRAM AND CAPITAL BUDGET TO REALLOCATE FOUR HUNDRED FIFTY THOUSAND DOLLARS (\$450,000) OF FISCAL YEAR 19 GENERAL FUND "PAY-GO" FROM THE STARS AND ADS-B EQUIPMENT PROJECT TO THE RUNWAY 14-32 EXTENSION PROJECT FOR THE SALISBURY-OCEAN CITY: WICOMICO REGIONAL AIRPORT.

WHEREAS, pursuant to Section 704 of the Wicomico County Charter titled "Capital Program and Budget," the County Council may, upon recommendation of the County Executive, after public hearing, amend the adopted Capital Program and Budget; and

WHEREAS, the Capital Program and Budget for Fiscal Years 2019 – 2023, adopted by Resolution No. 18-2018, on February 20, 2018, included Six Hundred Thousand Dollars (\$600,000) for the STARS and ADS-B Equipment project for the Salisbury-Ocean City: Wicomico Regional Airport; and

WHEREAS, the Federal Aviation Administration (FAA) no longer supports the STARS system; and

WHEREAS, the Airport Manager is requesting an amendment to the Capital Improvement Program and Capital Budget to reallocate Four Hundred Fifty Thousand Dollars (\$450,000) of Fiscal Year 19 General Fund "Pay-Go" from the STARS and ADS-B Equipment Project to the Runway 14-32 Extension Project for an Environmental Assessment in Fiscal Year 19; and


WHEREAS, a public hearing was held on October 2, 2018, to reallocate said funding in the Capital Program and Budget for fiscal years 2019-2023.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland, that the Fiscal Years 2019 - 2023 Capital Program and Budget is hereby approved as amended by reallocating Four Hundred Fifty Thousand Dollars (\$450,000) of Fiscal Year 19 General Fund "Pay-Go" from the STARS and ADS-B Equipment Project to the Runway 14-32 Extension Project for an Environmental Assessment in Fiscal Year 2019.


