A RESOLUTION AUTHORIZING THE COUNTY EXECUTIVE TO ACCEPT A GRANT AWARD FROM THE MARYLAND AVIATION ADMINISTRATION (MAA), IN THE AMOUNT OF ONE HUNDRED FORTY-FIVE THOUSAND THREE HUNDRED FIFTY-FIVE DOLLARS (\$145,355), FOR "AIRFIELD MARKING" AT THE SALISBURY-OCEAN CITY: WICOMICO REGIONAL AIRPORT.

WHEREAS, the Maryland Aviation Administration (MAA) offers grants to public agencies for the planning and development of public-use airports; and

WHEREAS, the Salisbury-Ocean City: Wicomico Regional Airport submitted a grant application and has received grant funding, in the amount of One Hundred Forty-Five Thousand Three Hundred Fifty-Five Dollars (\$145,355), from the Maryland Aviation Administration for the remarking of airfield paved surfaces that includes the preparation and painting of marking of 2 runways, 11 taxiways, and 2 aprons; and

WHEREAS, the total cost of the "Airfield Marking" project is One Hundred Ninety-Three Thousand Eight Hundred Seven Dollars (\$193,807); and

WHEREAS, the "Airfield Marking" project will be funded as follows: MAA Grant - \$145,355; Wicomico County Airport Aero Maintenance and Repairs Account (52030052-520031) \$48,452; and

WHEREAS, the County Executive recommends the acceptance of the MAA grant award for work associated with the "Airfield Marking" project; and

WHEREAS, the Director of Finance has certified that the Airport has funds available in its Aero Maintenance and Repairs Account (52030052-520031) for the local contribution.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland as follows:


1. The County Executive is hereby authorized to accept a grant award, in the amount of One Hundred Forty-Five Thousand Three Hundred Fifty-Five Dollars (\$145,355), from the Maryland Aviation Administration for " Airfield Marking" at the Salisbury-Ocean City: Wicomico Regional Airport.
2. The local contribution, in the amount of Forty-Eight Thousand Four Hundred Fifty Two Dollars (\$48,452) for the "Airfield Marking" project shall be paid from the Aero Maintenance and Repairs Account (52030052-520031).
3. Upon receipt of the Maryland Aviation Administration grant award, a new project number is to be established within Fund 31.

4. The Maryland Aviation Administration grant award shall be applied to the new grant project number established within Fund 31 once accepted.
