**Resolution No. 112-2018**

Introduced by: The President of the Council at the request of the County Executive

A RESOLUTION TO AMEND THE FISCAL YEARS 2014-2018 CAPITAL IMPROVEMENT PROGRAM AND CAPITAL BUDGET TO TRANSFER FIVE HUNDRED THOUSAND DOLLARS (\$500,000) FROM PROJECT #15104 (LOWER RIVER DMP SITE) TO PROJECT #15105 (MIDDLE RIVER DMP SITE) AND TO RENAME PROJECT #15105 TO "WICOMICO RIVER DMP SITE."

WHEREAS, pursuant to Section 704 of the Wicomico County Charter titled "Capital Program and Budget," the County Council may, upon recommendation of the County Executive, after public hearing, amend the adopted Capital Program and Budget; and

WHEREAS, the Capital Program and Budget for Fiscal Years 2014 – 2018, adopted by Resolution No. 22-2013 on March 5, 2013 included Five Hundred Thousand Dollars (\$500,000) for Project #15104 (Lower River DMP Site); and

WHEREAS, Public Works requests a Capital Program and Budget transfer from Project #15104 (Lower River DMP Site) to Project #15105 (Middle River DMP Site) in the amount of Five Hundred Thousand Dollars (\$500,000), and after said transfer Public Works requests that Project #15105 be renamed "Wicomico River DMP Site"); and


WHEREAS, a public hearing was held on October 16, 2018, regarding the transfer of Five Hundred Thousand Dollars (\$500,000) from Project #15104 to Project #15105 and to rename Project #15105 "Wicomico River DMP Site" in the Fiscal Years 2014-2018 Capital Program and Budget.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland, that the Fiscal Years 2014 - 2018 Capital Program and Budget is hereby approved as amended to transfer Five Hundred Thousand Dollars (\$500,000) from Project #15104 (Lower River DMP Site) to Project #15105 (Middle River DMP Site), and to rename Project #15105 to "Wicomico River DMP Site."
