Resolution No. 113-2018

Introduced by: The President of the Council at the request of the County Executive

A RESOLUTION DECLARING THAT PEDIATRIC CARDIOLOGY OF MARYLAND, LLC AND PCOM HOLDINGS LLC ARE ELIGIBLE TO RECEIVE ENTERPRISE ZONE BENEFITS IN CONNECTION WITH PROPERTY AND A BUSINESS LOCATED AT 560 RIVERSIDE DRIVE, SUITE B102, SALISBURY, MARYLAND.

WHEREAS, the City of Salisbury, Maryland and Wicomico County created an Enterprise Zone on June 6, 1983, for the purpose of encouraging economic development of the area encompassed within the boundaries of such zone; and

WHEREAS, the Enterprise Zone was created under authority granted by the State of Maryland; and

WHEREAS, State law permits certain benefits to be extended to businesses that locate or expand in the Enterprise Zone provided that they meet certain standards; and

WHEREAS, the City of Salisbury and Wicomico County have also established certain standards, which must be met in order for a business to be deemed eligible to receive Enterprise Zone benefits; and

WHEREAS, Pediatric Cardiology of Maryland, LLC and PCOM Holdings LLC meet the standards set forth in the State Code and in local regulations to be eligible to receive Enterprise Zone benefits; and


WHEREAS, James D. Telep, MD, representing Pediatric Cardiology of Maryland, LLC and PCOM Holdings LLC has requested that the companies be designated as eligible for Enterprise Zone benefits because of its investment of more than \$50,000 at the property located in the Enterprise Zone at 560 Riverside Drive, Suite B102, Salisbury, Maryland and for the hiring of two or more new full time employees.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland that Pediatric Cardiology of Maryland, LLC AND PCOM Holdings LLC be designated as eligible to receive the benefits of the Enterprise Zone effective upon the adoption of this Resolution.
