Introduced by: The President of the Council at the request of the County Executive

A RESOLUTION APPROVING A TRANSFER BETWEEN MAJOR CATEGORIES OF THE WICOMICO COUNTY BOARD OF EDUCATION OPERATING BUDGET FOR FISCAL YEAR 2018-2019; TRANSFERRING A TOTAL OF \$265,000.

WHEREAS, Section 5-105 of the Education Article of the Annotated Code of Maryland provides that the Board of Education shall notify the County Council of the source and amount of nonlocal funds received after the adoption of the annual budget, as well as the manner of spending said funds; and

WHEREAS, Section 5-105 further provides that a transfer between major categories of the budget of a County Board of Education shall be made only with the approval of the County Council; and

WHEREAS, if a County Council fails to take action on a written request for a transfer between major budget categories within 30 days of receipt of the request, the failure to take action constitutes approval thereof; and

WHEREAS, The County Council has received a request from the Board of Education to approve a transfer in the FY 2018-2019 current operating fund budget; and

WHEREAS, the Board of Education has indicated that the funds are available for transfer from the respective category.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland that the transfers between major categories of the FY 2018-2019 operating fund budget of the Wicomico County Board of Education, shown on the attached Exhibit A, are approved.
