A RESOLUTION TO APPOINT THE BOARD OF MANAGERS OF
VARIOUS PUBLIC DRAINAGE ASSOCIATIONS WITHIN WICOMICO COUNTY.

WHEREAS, The Annotated Code of Maryland, Article 25 "County Commissioners" subtitle "Drainage Lands", authorizes the formation of "Public Drainage Associations" as a political subdivision of the State and a body politic and corporate; and

WHEREAS, Section 65 of the aforesaid article authorizes and directs the County Commissioners to appoint a person or persons to the Board of Managers for the ensuing year when an annual meeting has not been called or when there is not a quorum present.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland, as follows:




