A RESOLUTION MAKING A SUPPLEMENTAL APPROPRIATION FROM CONTINGENCY TO THE STATE’S ATTORNEY’S OFFICE IN THE AMOUNT OF THIRTY-THREE THOUSAND, EIGHT HUNDRED TWENTY-TWO DOLLARS AND SIXTY-EIGHT CENTS (\$33,822.68).

WHEREAS, Section 709 of the Wicomico County Charter authorizes and empowers the Wicomico County Council, upon the request of the County Executive, to make supplementary appropriations from the unexpended and unencumbered funds set aside for contingencies in the County budget; and

WHEREAS, the State’s Attorney’s Office has incurred expenses that have depleted the office’s budget for FY 11; and

WHEREAS, the State’s Attorney has requested funding to pay its estimated expenses for the remainder of the current fiscal year; and

WHEREAS, the Director of Finance has certified that the appropriation to be transferred is not encumbered and funds are available for transfer.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland, that the following supplementary appropriation of funds is authorized and approved:
