Introduced by: The President of the Council at the request of the County Executive

A RESOLUTION MAKING A SUPPLEMENTAL APPROPRIATION FROM CAPITAL CONTINGENCY TO THE DEPARTMENT OF RECREATION, PARKS & TOURISM IN THE AMOUNT OF ONE HUNDRED THIRTY-FOUR THOUSAND DOLLARS (\$134,000.00).

WHEREAS, Section 709 of the Wicomico County Charter authorizes and empowers the Wicomico County Council, upon the request of the County Executive, to make supplementary appropriations from the unexpended and unencumbered funds set aside for contingencies in the County budget; and

WHEREAS, the Department of Recreation, Parks & Tourism has requested funding to replace four HVAC units at Arthur W. Perdue Stadium that are in need of immediate replacement as well as funding for inspection services and specifications, drawings and bid documents for an additional eight SIX failed HVAC units; and

WHEREAS, the Director of Finance has certified that the appropriation to be transferred is not encumbered and funds are available for transfer; and

WHEREAS, when you close a bond and move forward the proceeds, the entire amount of the proceeds must move forward at one time; and

WHEREAS, the balance of the proceeds is to be put into County Capital Contingency for future capital projects.




