A RESOLUTION TO APPOINT THE BOARD OF MANAGERS OF
VARIOUS PUBLIC DRAINAGE ASSOCIATIONS WITHIN WICOMICO COUNTY.

WHEREAS, The Annotated Code of Maryland, Article 25 “ County Commissioners” subtitle “Drainage Lands”, authorizes the formation of “Public Drainage Associations” as a political subdivision of the State and a body politic and corporate; and

WHEREAS, Section 59 of the aforesaid article provides for the election of a Board of Managers by landowners within the Public Drainage Association; and

WHEREAS, Section 65 of the aforesaid article authorizes and directs the County Commissioners to appoint a person or persons to the Board of Managers for the ensuing year; and

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland, as follows:


The following persons, submitted by the respective Managers of the designated Public Drainage Association are hereby appointed to the Board of Managers of their respective Associations:




