A RESOLUTION TRANSFERRING CAPITAL FUNDS FROM BOND CONTINGENCY TO THE WETIPQUIN BRIDGE PROJECT ACCOUNT IN THE AMOUNT OF EIGHTY-THREE THOUSAND EIGHT HUNDRED AND NINETY-THREE DOLLARS.

WHEREAS, Section 712 of the Wicomico County Charter authorizes and empowers the Wicomico County Council, upon the request of the County Executive, to make a transfer of appropriation of funds among projects expressly set forth in the capital budget; and

WHEREAS, Section 712 of the Wicomico County Charter provides that the amount of the total costs of any one (1) project shall not exceed one hundred twenty-five percent (125%) of the authorized amount specified in the enabling legislation; and

WHEREAS, the State of Maryland has increased its requirement for the County's share of the costs of the Wetipquin Bridge project; and

WHEREAS, the Wetipquin Bridge project, therefore, requires additional funds up to the limit allowed by the Charter.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland, that the following appropriation of funds transfer is authorized and approved:




