**AN ACT** to amend the Wicomico County Classification and Pay Plan by the addition of a new position to the job classification in the Department of Recreation, Parks and Tourism and establishing a job title and grade.

### PREAMBLE

The Wicomico County Classification and Pay Plan provides a system of standardized title and common job language critical to the effective administration of County personnel.

The County Executive, at the request of the Director of the Department of Recreation, Parks and Tourism, and with the support of the Tourism Board, recommends the establishment of a new position titled "Housing Services Coordinator" within the Tourism section of the Department to ensure continuity of operations for the foreseeable future.

**SECTION I.** BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that the Wicomico County Classification and Pay Plan is hereby amended as follows:

The following specified position is added to the job classification system and grade is hereby added:

#### Department of Recreation, Parks and Tourism


<u>Classification</u>	<u>Grade</u>
Housing Services Coordinator	19 (\$36,216 - \$72,521)

**SECTION II.** Be it Further Enacted, that this Bill shall not be codified in the Wicomico County Code.


**SECTION III.** Be It Further Enacted, that this Bill shall be known as Bill No. 2012-18 of Wicomico County, Maryland and shall take effect sixty (60) days after its enactment, unless a proper Petition for Referendum thereof shall be filed prior to said date; in which event, the Bill shall not take effect until the expiration of thirty (30) days following the approval of this Bill by a majority of the qualified voters of the County voting in any such referendum.
