AN ACT to amend Chapter 37 of the Wicomico County Code, titled "Ethics Law," Article II, titled "Ethics Commission," Section 37-5, titled "Ethics Commission" to provide for the appointment of an alternate member to the Ethics Commission who shall serve for a three-year term.

WHEREAS, it appears advisable, upon the favorable recommendation of the County Executive, after public hearing, to amend Section 37-5 of the Wicomico County Code to provide for the appointment of an alternate member to the Ethics Commission who shall serve for a three-year term.

SECTION I: BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that Chapter 37 of the Wicomico County Code, titled "Ethics Law," Article II, titled "Ethics Commission," Section 37-5, titled "Ethics Commission" be and the same is hereby amended to read as follows:

Chapter 37
Ethics Law

* * *

Article II
Ethics Commission

§37-5 Ethics Commission.

A. There is a Wicomico County, Maryland, Ethics Commission, which shall be composed of three members AND ONE ALTERNATE MEMBER appointed by the County Executive and confirmed by the County Council of Wicomico County, Maryland. The members:

- (1) Shall serve for staggered terms of three years; THE ALTERNATE MEMBER SHALL SERVE A THREE-YEAR TERM.
- (2) May continue to serve until successor is duly appointed and qualified.
- (3) Shall elect a Chairman from among them, who shall serve a term of one year and who may be reelected.

SECTION II. BE IT FURTHER ENACTED THAT this Bill shall be known as Bill No. 2013-09 of Wicomico County, Maryland, and shall take effect sixty (60) days after its final passage, unless a proper Petition for Referendum thereof shall be filed prior to said date, in which event,

the Bill shall not take effect until the expiration of thirty (30) days following the approval of this Bill by a majority of the qualified voters of the County voting in any such referendum.


