Addendum # 2

Bid: Ceiling Painting of Civic Center Normandy Arena

A pre-bid walkthrough was held at the Wicomico Youth and Civic Center on February 25, 2016 at 2:00 PM. Bidders attended and viewed the job site. A sign-in sheet of attendees follows this document.

Bidders had the opportunity to ask questions about the project. The following are clarifications provided and answers to questions:

- The bid is for the painting of the grid plus the ceiling tiles.
- The number of coats is not specified in the bid documents, but painting should be done per manufacturer's specifications for coverage.
- Most of the empty tiles will be patched before the project start date.
- Please include in the "total project price" the painting of 100 extra ceiling tiles, which are the same size as the tiles already in the ceiling (size of each tile is 2'x4'). These extra tiles will be used in storage in case of need. The tiles will just be painted, no extra maintenance or installation is necessary.
- There is a truck bay where the lifts or any other equipment needed by the successful vendor can enter. A full 18 wheeler can fit through the truck bay.
- The trusses and curtains that hang from the ceiling will be removed for painting, as needed, by coordinating with Wicomico County Youth and Civic Center staff.
- Please coordinate the painting schedule and areas to be painted with Youth and Civic Center staff. Depending on chair or event needs, a particular portion of the ceiling may need to be painted over other areas.

- There is no need to cover or mask the chairs or walls as the chairs are being replaced beginning on April 11 and the walls will be repainted at a later date. The signage, windows, sprinklers, HVAC, lighting, speaker cluster, and other devices must be covered or protected.
- The windows where work can be completed by the vendor are as follows:
 - March 10 (need to vacate by 5PM)
 - March 14-18 (need to vacate by 5pm of the 18th)
 - March 21-April 1st (need to vacate by 11pm on the 1st)
- On these work windows, the masked areas may stay in place until the vendor needs to vacate (on the 10th, 18th, and 1st). There is no need to break down masking after each work day.
- Vendors may work from 7:00 AM to 11:00 PM each day, unless vacating earlier is required as noted on the above work window list.
- There are sheds which are locked and some small internal storage areas so vendors may mobilize on site.
- No bid bond, performance bond, or work bond is required for this bid.
- Questions must be received by March 1st, 2016 at 5:00 PM. Questions received after this date and time cannot be answered.
