Addendum # 1 Printing of Visitor's Guide

NOTICE TO ALL BIDDERS AND PLANHOLDERS

The Bid Documents for the above-referenced Project are modified as set forth in this Addendum. The original Bid Documents and any previously issued addenda remain in full force and effect, except as modified by this Addendum, which is hereby made part of the Bid Documents. Vendors will take this Addendum into consideration when preparing and submitting a Bid, and shall acknowledge receipt of this Addendum in the space provided in the Bid Documents.

BID SUBMITTAL DEADLINE

The Bid submittal time has not been changed.

1.0 – BID SPECIFICATIONS

The following changes have been made to the Bid Documents.

Item	Description
1.1	On Page 14, FORM OF BID, Additional Item 1, CHANGE pages to quantity. "Quantity: Per unit price for +/- quantity in increments of 1,000."

2.0 – QUESTIONS AND ANSWERS

The following questions and answers are provided as a matter of information to clarify issues raised about the Bid Documents.

Item	Questions and Answers
2.1	<p>Q. On the Page Count: Per unit price for +/- pages in increments of four (4) how many increments of 4 would you like us to go to. The prices widely vary considering the page count. 60, 64, 68 and 72 plus cover ok, or would you like more?</p> <p>A. When we've done bids like this in the past, printers just provide the number for increments of four, and then once we determine the page count, we multiply that price by the number of increments we are adding or subtracting, then add or subtract that number from the base price. For example, if it's +/- \$XX per increment of 4 pages, and we need 8 additional pages – or 2 increments of 4 – we just multiply \$XX x 2 increments = \$XX. The County is requesting a base price for 30,000 copies, 60 pages, plus cover. If additional pages are needed the +/- price will be added to the base price.</p>
2.2	<p>Q. Do you remain firm on the 8.5" x 11" final trim size?</p> <p>A. Yes, we are firm on the 8.5" x 11" final trim size.</p>
2.3	<p>Q. Will it be necessary, for any Vendor who responded to this particular bid request in December, to supply ALL bid documents again along with the new bid? I'd like to just submit the new quote since you already have all of the other required documents and nothing has changed since that submission. Correct me if I'm wrong, but it looks like the only difference between the December bid and this one is you're asking for the cost of +/- books in 1000 increments and +/- pages in increments of (4)?</p>

	A. Bid documents are not needed from previous bids. There are a few other differences in the bid, such as the option to extend to three years, etc. Vendors must complete all requirements of this bid even if they bid on a previous bid.
2.4	Q. Are you willing to accept a finished size of 8.375" x 10.875"? A. We are firm on 8.5" x 11" final trim size.
