| 3.1   | <p>Q. The plans show that the existing blacktop is to be removed and then 4” of CR-6 to be added. Is this correct? Are they going to be milling any of the existing parking lot?</p> <p>A. Yes, that is the current plan. When we started the job, we discussed the option of milling and repaving, but given the minimal thickness of the asphalt, we don’t think a mill would work. We can still overlay, however. But at the time we discussed it (given the amount of issues we have out there with roots and such) we made the decision to go with a full rebuild. Removing the soil cement option leaves us only with the new stone/asphalt option.</p> |
