AN ACT TO AMEND AND TRANSFER THE APPROPRIATION FROM ESTIMATED CONTRIBUTION TO FUND BALANCE ACCOUNT AND THE USE OF PRIOR YEAR FUNDS BALANCE ACCOUNT TO SOLID WASTE ENTERPRISE FUND, CELL 9 CONSTRUCTION PROJECT ACCOUNT IN THE ANNUAL BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2019.

WHEREAS, on June 14, 2018, the County Council enacted Legislative Bill No. 2018-05, the Annual Budget and Appropriation Bill, adopting the Operating Budget for the fiscal year ending June 30, 2019; and

WHEREAS, the Public Works Department is requesting a transfer of funds to pay for the Cell 9 Construction Project; and

WHEREAS, the Deputy Director of Finance has certified that the appropriation to be transferred is not encumbered and funds are available for transfer.

SECTION I: BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that "The Annual Budget and Appropriation Bill," be and is hereby amended as follows:

1. Transfer from Account: Estimated Contribution to Fund Balance Account-- 51030051-599000 - \$567,824.26;
2. Transfer from Account: Use of Prior Year Funds Balance Account-- 51A0851-421110 - \$334,158.74.
3. Transfer to Account: Solid Waste Enterprise Fund, Cell 9 Construction Project Account -- 51030051-540009-PWS13 - \$901,983.00.

SECTION II: BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that subject to the laws of Maryland, the Wicomico County Charter, and the Wicomico County Code relating to budgetary and fiscal procedures, the accounts are amended to reflect a transfer to pay grant matching funds for the fiscal year beginning July 1, 2018, and ending June 30, 2019.

SECTION III: BE IT FURTHER ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION

THAT this bill shall be known as Legislative Bill No. 2018-5 – Amendment No. 2 and shall take effect sixty (60) days after its enactment.
