AN ACT to amend Chapter 47, titled "Library System", Section 47-5, titled "Membership" to extend the membership term for the Board of Library Trustees.

PREAMBLE

WHEREAS, The Maryland Annotated Code, Education Article, Section 23-403 (c) (1) provides that the term of a member of the Board of Trustees for the county public library system shall be 5 years; and

WHEREAS, it appears advisable upon the recommendation of the Executive, that the County Code be amended to extend the membership term for the Board of Library Trustees from three (3) years to five (5) years, consistent with Maryland State Law.

SECTION I. BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that Chapter 47, entitled "Library System," Section 47-5, entitled "Membership." be and the same is hereby amended and enacted to read as follows:

Chapter 47
LIBRARY SYSTEM

Section 47-5. Membership.


Each member of the Board of Library Trustees shall serve for a term of ~~three~~ FIVE years and until a successor is appointed and qualified. The terms of the members of the Board shall be staggered as required by the terms of the members serving on the Board as of July 1, 1979. The members shall be chosen on the basis of character, ability and demonstrated interest in library matters and shall be residents of Wicomico County.

SECTION II. BE IT FURTHER ENACTED THAT this Bill shall be known as Bill No. 2008-7 of Wicomico County, Maryland and shall take effect sixty (60) days after its enactment, unless a proper Petition for Referendum thereof shall be filed prior to said date; in which event, the Bill shall not take effect until the expiration of thirty (30) days following the approval of this Bill by a majority of the qualified voters of the County voting in any such referendum.


