A RESOLUTION APPOINTING MEMBERS TO THE WICOMICO COUNTY COMMISSION FOR WOMEN.

WHEREAS, the Annotated Code of Maryland, Human Services Article, Section 2-402, provides for the establishment of a Maryland Commission for Women; and

WHEREAS, Wicomico County supports the mission of the Maryland Commission for Women in promoting social, political and economic equality for women in Maryland; and

WHEREAS, Section 413 of the Wicomico County Charter provides for the County Executive to appoint and for the County Council to confirm nominees to Wicomico County Boards and Commissions created by law; and

WHEREAS, the County Executive has recommended nominees to the Wicomico County Commission for Women; and

WHEREAS, the County Council ratifies the County Executive's special trust and confidence in the abilities of the nominees; and

WHEREAS, the Commission shall select a Chair ~~and designate two alternates~~ from the following list of individuals once membership is established; the names of the ~~alternates and~~ Chair shall be reported to the County so the membership list can be updated; and

WHEREAS, THERE SHALL BE FIFTEEN members ON THE COMMISSION THAT shall serve a staggered term of three years with term expirations as indicated below.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Wicomico County, Maryland that the following individuals are appointed to the Wicomico County Commission for Women to serve from the passage of this resolution to the term expiration date shown below or until a successor is appointed and confirmed:




