A RESOLUTION TO MAKE AN APPROPRIATION OF FUNDS TO VARIOUS SHERIFF DEPARTMENT ACCOUNTS FROM UNANTICIPATED REVENUE IN THE AMOUNT OF SEVENTY-NINE THOUSAND, THREE HUNDRED FIFTY DOLLARS AND EIGHTY-FOUR CENTS (\$79,350.84).

WHEREAS, Section 709 of the Wicomico County Charter authorizes and empowers the Wicomico County Council, upon the request of the County Executive, to make appropriations from revenue receipts in excess of those budgeted; and

WHEREAS, the Sheriff's Department for Wicomico County has received unanticipated revenue from the following sources: State of Maryland (Sex Offender Reimbursement)-\$37,600; Salisbury Scrap Metal- \$3,466.60; Travelers (total loss on 2008 Crown Victoria)-\$7,469.64; Travelers (total loss on 2013 Dodge Charger)-\$27,769.64; and Travelers (total loss on 2005 Crown Victoria)-\$3,044.96.

WHEREAS, the Sheriff's Department desires that said revenue be allocated among the accounts specified below; and

WHEREAS the Director of Finance has certified that the funds are available for appropriation.

NOW, THEREFORE, BE IT RESOLVED, by the Wicomico County Council that the following appropriations of funds are authorized and approved:


