A RESOLUTION TO MAKE AN APPROPRIATION OF FUNDS TO VARIOUS SHERIFF DEPARTMENT ACCOUNTS FROM UNANTICIPATED REVENUE IN THE AMOUNT OF SEVENTY-EIGHT THOUSAND, EIGHT HUNDRED TWENTY DOLLARS AND THRITY CENTS (\$78,820.30).

WHEREAS, Section 709 of the Wicomico County Charter authorizes and empowers the Wicomico County Council, upon the request of the County Executive, to make appropriations from revenue receipts in excess of those budgeted; and

WHEREAS, the Sheriff's Department for Wicomico County has received unanticipated revenue from the following sources: Federal Emergency Management Agency ("FEMA") (reimbursement for Hurricane Sandy overtime expenditures)- \$23,448.95; Salisbury Scrap Metal (proceeds from abandon vehicle)- \$440; RedSpeed (monthly citation income)-\$42,193; proceeds from the sale of 10 Sheriff's vehicles that exceeded useful life and surplus light bars-\$12,738.35; and

WHEREAS, the Sheriff's Department desires that said revenue be allocated among the accounts specified below; and

WHEREAS the Director of Finance has certified that the funds are available for appropriation.

NOW, THEREFORE, BE IT RESOLVED, by the Wicomico County Council that the following appropriations of funds are authorized and approved:




