**Resolution No. 54-2013**

Introduced by: The President of the Council at the request of the County Executive

A RESOLUTION AUTHORIZING THE COUNTY EXECUTIVE TO ACCEPT A GRANT AWARD FROM THE MARYLAND DEPARTMENT OF NATURAL RESOURCES-PROGRAM OPEN SPACE IN THE AMOUNT OF \$103,500.

WHEREAS, the Maryland Department of Natural Resources through Program Open Space administers funds made available to local communities for open and recreational areas; and

WHEREAS, the Department of Recreation, Parks & Tourism desires to reconstruct the double tennis court and replace the playground equipment at the Crooked Oak Playground; and

WHEREAS, the Crooked Oak Playground: Tennis Court Restoration and Play Equipment project was approved in the Fiscal Year 2013 Capital Improvement Program for a total project cost of \$115,000 to be funded under Fund 32 Project Number 13120 as follows: (1) estimated contribution from the State of Maryland in the amount of \$90,000. (2) County appropriation in the amount of \$25,000 (an amount that has already been appropriated to the project); and

WHEREAS, the Department of Recreation, Parks & Tourism submitted an application for Program Open Space funds for the Crooked Oak Playground: Tennis Court Restoration and Play Equipment project and has been awarded a grant in the amount of \$103,500, with a needed local contribution of \$11,500, for a total project cost of \$115,000; and

WHEREAS, the grant award provides for a different funding split than what was previously identified in the Fiscal Year 2013 Capital Improvement Program as the Program Open Space grant award provides an additional contribution of \$13,500; and

WHEREAS, the County Executive recommends the acceptance of the full grant award from the Maryland Department of Natural Resources-Program Open Space; and

WHEREAS, the now extra funding contribution of \$13,500 from the FY13 CIP appropriation is to be transferred to Capital-Unassigned Funding (3201008-540008).

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland as follows:

1. The County Executive is hereby authorized to accept the full grant award from the Maryland Department of Natural Resources-Program Open Space in the amount of \$103,500.
2. The previously appropriated county contribution, now excess in the amount of \$13,500, shall be transferred to Capital-Unassigned Funding (3201008-540008).


