A RESOLUTION AUTHORIZING THE COUNTY EXECUTIVE TO SUBMIT AN AIRPORT SPECIAL GRANT APPLICATION AND ACCEPT A GRANT AWARD IN THE AMOUNT OF SIXTY-ONE THOUSAND FIVE HUNDRED DOLLARS (\$61,500) FROM THE MARYLAND AVIATION'S OFFICE OF REGIONAL AVIATION ASSISTANCE.

WHEREAS, the Maryland Aviation Administration offers grants to public agencies for the planning and development of public-use airports; and

WHEREAS, the HVAC system and baggage belts located in the Terminal Building of the Salisbury-Ocean City: Wicomico Regional Airport are in need of replacement; and

WHEREAS, the update design, repackaging and bidding phase of the Terminal Building's HVAC and baggage belt replacement project cost is Eighty-Two Thousand Dollars (\$82,000); and


WHEREAS, the Salisbury-Ocean City: Wicomico Regional Airport desires to submit an Airport Special Grant Application to the Maryland Aviation Administration in the amount of Sixty-One Thousand Five Hundred Dollars (\$61,500) to cover seventy-five percent (75%) of the HVAC and baggage belt replacement cost; the remaining twenty-five percent (25%) will be a local contribution in the amount of Twenty Thousand Five Hundred Dollars (\$20,500); and


WHEREAS, the Director of Finance has certified that the Airport has funds available in its Passenger Facility Charge account (AP007) for the local contribution.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland that the County Executive is authorized to submit a grant application and accept a grant award from the Maryland Aviation Administration's Office of Regional Aviation Assistant, in the amount of Sixty-One Thousand Five Hundred Dollars (\$61,500), for the Terminal Building HVAC and baggage belt replacement project.


