**Resolution No. 104-2014**

Introduced by: The President of the Council at the request of the County Executive

A RESOLUTION AUTHORIZING THE COUNTY EXECUTIVE TO SUBMIT A GRANT APPLICATION AND ACCEPT A GRANT AWARD FROM THE CHESAPEAKE BAY TRUST AND MARYLAND STATE AGENCY 2014-2015 WATERSHED ASSISTANCE GRANT PROGRAM – TWO-YEAR MILESTONE, IN AN AMOUNT UP TO SEVENTY THOUSAND DOLLARS (\$70,000).

WHEREAS, the Chesapeake Bay Trust and the Maryland Departments of Natural Resources and Environment is accepting applications under the Watershed Assistance Grant Program for watershed restoration and protection projects as well as programmatic development projects; and

WHEREAS, the Department of Planning, Zoning and Community Development and the Department of Public Works desire to submit an application to the Watershed Assistance Grant Program requesting funds in an amount up to Seventy Thousand Dollars (\$70,000), with a local match of Forty Thousand, Two Hundred and Twenty-One Dollars (\$40,221), for project design assistance; and

WHEREAS, the local match will consist of Twenty-Five Thousand Dollars (\$25,000) cash match and Fifteen Thousand, Two-Hundred and Twenty-One Dollars (\$15,221) of in-kind match from County expenditures to prepare the preliminary design concepts; and

WHEREAS, the Director of Finance certifies that cash match is available from County Capital Project Fund 32 Project Number 14120; and

WHEREAS, the County Executive recommends the submission of a grant application to the Chesapeake Bay Trust and Maryland State Agency 2014-2015 Watershed Assistance Grant Program-Two Year Milestone.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland as follows:

1. The County Executive is hereby authorized to submit a grant application to the Chesapeake Bay Trust and Maryland State Agency 2014-2015 Watershed Assistance Grant Program-Two Year Milestone.
2. The County Executive is hereby authorized to accept a grant award in an amount up to Seventy Thousand Dollars (\$70,000), with a local match of Forty Thousand, Two Hundred and Twenty-One Dollars (\$40,221).
3. The County Executive is to establish a grant Project Number 14120 under State Grant Fund 02, and transfer the matching funds amount of up to Twenty-Five Thousand Dollars (\$25,000), upon acceptance of the grant, from

existing County Capital Project Fund 32 Project Number 14120 to the Fund 02 Project 14120.


