A RESOLUTION MAKING A SUPPLEMENTAL APPROPRIATION FROM WICOMICO COUNTY URBAN SERVICES COMMISSION FUND BALANCE TO THE MORRIS MILL URBAN SERVICE DISTRICT WATER PROJECT IN THE AMOUNT OF ONE MILLION DOLLARS (\$1,000,000).

WHEREAS, a number of private water wells in the Morris Mill Road area have been contaminated with Trichloroethylene (TCE)-constituting an imminent health hazard; and

WHEREAS, the Wicomico County Urban Services Commission, at a public hearing held on October 14, 2013, deemed it necessary for the health, safety and welfare of the residents to create an urban service district for the purpose of providing a potable water system to the property owners of the Morris Mill Road area; and

WHEREAS, funding has been secured from the State of Maryland and the United States Department of Agriculture-Rural Development for the installation of a water supply system; and

WHEREAS, the Urban Service Commission will need to forward fund a portion of the project costs for the water supply system prior to receipt of the State and Federal funding by the County; and

WHEREAS, the Wicomico County Urban Services Commission desires to forward fund a portion of the project costs in the amount of One Million Dollars (\$1,000,000) to the Morris Mill Urban Service District Water Project; and

WHEREAS, upon receipt of the State and Federal funding by the County, the Morris Mill Urban Service District Water Project will reimburse the Wicomico County Urban Services Commission Fund Balance One Million Dollars (\$1,000,000); and

WHEREAS, the Director of Finance has certified that the appropriation to be transferred is not encumbered and funds are available for transfer.

NOW, THEREFORE, BE IT RESOLVED, by the Wicomico County Urban Services Commission as follows:

1. The following supplementary appropriation of funds is authorized and approved:

From: Urban Services Commission Fund Balance	\$1,000,000
To: Morris Mill Urban Service District Water Project Inter-fund loan 03A0524-456000-314MM	\$1,000,000

2. Upon receipt of the State and Federal funding for the Morris Mill Urban Service District Water Project, the Morris Mill Urban Service District Water Project shall reimburse the Wicomico County Urban Services Commission Fund Balance the sum of One Million Dollars (\$1,000,000).
