A RESOLUTION ACKNOWLEDGING, FOR THE PURPOSE OF A MANUFACTURER'S TAX EXEMPTION, A BUSINESS MERGER AND COMPANY NAME CHANGE FROM PERDUE FARMS, LLC TO PERDUE FOODS, LLC.

WHEREAS, Perdue Farms, Incorporated has previously been granted a manufacturer's tax exemption on machinery and equipment used in the conduct of business in Wicomico County; and

WHEREAS, Perdue Farms, Incorporated merged with Perdue Farms, LLC as evidenced by a "Certificate of Conveyance" filed with the Maryland State Department of Assessment and Taxation on September 28, 2012; and

WHEREAS, Perdue Farms, LLC changed the company name to Perdue Foods, LLC as evidence by "Articles of Amendment to Articles of Organization Perdue Farms LLC" filed with the Maryland State Department of Assessment and Taxation on October 23, 2012; and

WHEREAS, the County Council wishes to confirm the merger of Perdue Farms, Incorporated with Perdue Farms, LLC and the name change of Perdue Farms, LLC to Perdue Foods, LLC; and

WHEREAS, Perdue Foods, LLC has requested that the manufacturer's tax exemption previously granted to Perdue Farms, Incorporated be applied under the new company name.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland as follows:

- 1. The manufacturer's tax exemption granted to Perdue Farms, Incorporated be applied under the new company name of Perdue Foods, LLC.
2. This exemption shall continue from year to year, without further application or action by the Council; provided, however, that said exemption shall terminate on the first day of the taxable year in which said manufacturer shall cease its manufacturing, fabricating or assembly operations in the county.
