A RESOLUTION AUTHORIZING THE COUNTY EXECUTIVE TO ACCEPT A GRANT AWARD FROM THE MARYLAND DEPARTMENT OF NATURAL RESOURCES-PROGRAM OPEN SPACE IN THE AMOUNT OF TEN THOUSAND DOLLARS (\$10,000) AND TO CREATE A COUNTY FUNDED CAPITAL PROJECT FOR THE WINTERPLACE PARK OUTBUILDING ROOF REPLACEMENT.

WHEREAS, the Maryland Department of Natural Resources through Program Open Space administers funds made available to local communities for open and recreational areas; and

WHEREAS, the Department of Recreation, Parks & Tourism desires to replace the roof on the outbuilding at WinterPlace Park; and

WHEREAS, the Department of Recreation, Parks & Tourism submitted an application for Program Open Space funds and has been awarded a grant in the amount of \$10,000 to replace the roof on the outbuilding at WinterPlace Park, with a needed local contribution of \$10,000, for a total project costs of \$20,000; and

WHEREAS, the County Executive recommends the acceptance of the grant award from the Maryland Department of Natural Resources-Program Open Space; and

WHEREAS, the work on this project will not be substantially completed before the end of the fiscal year, June 30, 2013; and

WHEREAS, a new capital project in fund 32 is needed to track the funding for the WinterPlace Park outbuilding roof replacement project and to permit the funds to carry forward to the next fiscal year; and

WHEREAS, the needed local contribution in the amount of \$10,000 is to be transferred from the Equestrian Center Escrow account (72070060-520260-72016) to fund 32 for the WinterPlace Park outbuilding roof replacement project; and

WHEREAS, the Director of Finance has certified that the appropriation to be transferred is not encumbered and funds are available for transfer.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland as follows:


1. The County Executive is authorized to accept the grant award from the Maryland Department of Natural Resources-Program Open Space in the amount of ten thousand dollars (\$10,000).

2. A capital project is approved and is to be established with fund 32 with a specific project number assigned for the WinterPlace Park outbuilding roof replacement project.
3. An appropriation of funds in the amount of ten thousand dollars (\$10,000) from the Equestrian Center Escrow account (72070060-520260-72016) to fund 32 for the Winterplace Park outbuilding roof replacement project is authorized and approved.
