Introduced by: The President of the Council at the request of the County Executive

A RESOLUTION TO MAKE AN APPROPRIATION OF FUNDS TO THE SHERIFF'S OFFICE FROM UNANTICIPATED REVENUE IN THE AMOUNT OF FORTY-NINE THOUSAND, NINE HUNDRED THIRTY-FIVE DOLLARS AND ELEVEN CENTS (\$49,935.11).

WHEREAS, Section 709 of the Wicomico County Charter authorizes and empowers the Wicomico County Council, upon the request of the County Executive, to make appropriations from revenue receipts in excess of those budgeted; and

WHEREAS, the Sheriff's Office for Wicomico County has received unanticipated revenue from the following sources: (1) State of Maryland (Reimbursement of overtime hours for support of Maryland State Police Marijuana SWAT call-outs) -\$3,468.07; (2) State of Maryland (Sex Offender Reimbursement)-\$33,000; (3) Local Government Insurance Trust (total loss on 2005 Crown Victoria)- \$2,300; and (4) Department of Treasury (Seizure Number: 2012130300033801)- \$11,167.04. The total unanticipated revenue is \$49,935.11; and

WHEREAS, the Sheriff's Office desires that said revenue be allocated among the accounts specified below to cover overtime salary expenses, vehicle maintenance and equipment; and

WHEREAS, the Director of Finance has certified that the funds are available for appropriation.

NOW, THEREFORE, BE IT RESOLVED, by the Wicomico County Council that the following appropriations of funds are authorized and approved:




