**Resolution No. 93-2016**

Introduced by: The President of the Council at the request of the County Executive

A RESOLUTION MAKING A SUPPLEMENTAL APPROPRIATION FROM CONTINGENCY TO THE WOR-WIC TUITION SCHOLARSHIP FUND IN THE AMOUNT OF TWO HUNDRED ~~SIXTY-FIVE~~ TWELVE THOUSAND DOLLARS (~~\$265,000~~) (\$212,000).

WHEREAS, Section 709 of the Wicomico County Charter authorizes and empowers the Wicomico County Council, upon the request of the County Executive, to make supplementary appropriations from the unexpended and unencumbered funds set aside for contingencies in the County budget; and

WHEREAS, the proposed Annual Budget and Appropriation Bill contains Two Hundred Sixty-Five Thousand Dollars (\$265,000) for a Wicomico County Economic Scholarship Program; and

WHEREAS, it was determined that the funding for the Wicomico County Economic Scholarship Program would be placed in contingency until the program was formally approved, as reflected in Legislative Bill 2016-06 adopted on June 7, 2016; and

WHEREAS, Resolution No. 79-2016, adopted by the County Council on June 21, 2016 formally established a Wicomico County Economic Scholarship Program; and

WHEREAS, the County Executive and County Council now desire to transfer Two Hundred ~~Sixty-Five~~ TWELVE Thousand Dollars (~~\$265,000~~) (\$212,000) from contingency to the Wor-Wic Tuition Scholarship fund in order to implement the Wicomico County Economic Scholarship Program; and

WHEREAS, the Director of Finance has certified that the appropriation to be transferred is not encumbered and funds are available for transfer.


NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland, that the following supplementary appropriation of funds is authorized and approved:


