Introduced by: The President of the Council at the request of the County Executive

A RESOLUTION APPROVING A TRANSFER BETWEEN MAJOR CATEGORIES OF THE WICOMICO COUNTY BOARD OF EDUCATION OPERATING BUDGET FOR FISCAL YEAR 2017; TRANSFERRING A TOTAL OF SEVENTY-FIVE THOUSAND DOLLARS (\$75,000) AS SHOWN ON THE ATTACHED EXHIBIT A.

WHEREAS, Section 5-105 of the Education Article of the Annotated Code of Maryland provides that a transfer between major categories of the budget of a County Board of Education shall be made only with the approval of the County Council; and

WHEREAS, Section 5-105 further provides that if a County Council fails to take action on a written request for a transfer between major budget categories within 30 days of receipt of the request, the failure to take action constitutes approval thereof; and


WHEREAS, the County Council has received a request from the Board of Education to transfer Seventy-Five Thousand Dollars (\$75,000) between major categories of the Wicomico County Board of Education Operating Budget, as shown on the attached Exhibit A; and

WHEREAS, the Board of Education has indicated that the appropriation to be transferred is not encumbered and funds are available for transfer.


NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland that the transfer between major categories of the FY 2017 Wicomico County Board of Education Operating Budget shown on the attached Exhibit A is authorized and approved.



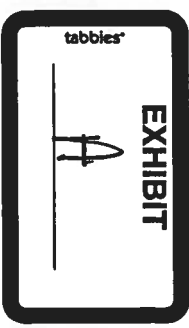

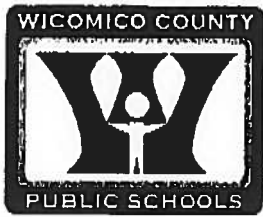
