**Resolution No. 50-2017**

A RESOLUTION APPROVING A REQUEST TO WAIVE THE LANDFILL TIPPING FEE, IN THE AMOUNT OF FIFTY-TWO DOLLARS AND EIGHTY CENTS (\$52.80), FOR A NEIGHBORHOOD CLEANUP EVENT SPONSORED BY THE WESTSIDE WICOMICO COUNTY LIONS CLUB, WESTSIDE COMMUNITY CENTER, WESTSIDE VOLUNTEER FIRE DEPARTMENT AND WESTSIDE CHURCHES.

WHEREAS, the Wicomico County Code, Chapter 141 entitled "Fees," Section 4 entitled "Department of Public Works" establishes a landfill tipping fee; and

WHEREAS, neighborhood cleanup events bring tremendous value to our neighborhoods by keeping our streets clean and create a sense of community pride; and

WHEREAS, a request has been made to waive the landfill tipping fee, in the amount of Fifty-Two Dollars and Eighty Cents (\$52.80), for a neighborhood cleanup event held on March 18, 2017 to dispose of roadside litter, trash and debris; and

WHEREAS, the County Executive recommends waiving the landfill tipping fee, in the amount of Fifty-Two Dollars and Eighty Cents (\$52.80), in support of the neighborhood cleanup event.

NOW, THEREFORE, BE IT RESOLVED, that the County Council of Wicomico County, Maryland does hereby grant a waiver of the landfill tipping fee, in the amount of Fifty-Two Dollars and Eighty Cents (\$52.80), following a neighborhood cleanup event held on March 18, 2017 sponsored by the Westside Wicomico County Lions Club, Westside Community Center, Westside Volunteer Fire Department and Westside Churches.
