A RESOLUTION TO MAKE AN APPROPRIATION OF FUNDS TO VARIOUS SHERIFF'S ACCOUNTS FROM UNANTICIPATED REVENUES IN THE AMOUNT OF NINETY-ONE THOUSAND, FIVE HUNDRED FOURTEEN DOLLARS AND NINETY-FIVE CENTS (\$91,514.95)

WHEREAS, Section 709 of the Wicomico County Charter authorizes and empowers the Wicomico County Council, upon the request of the County Executive, to make appropriations from revenue receipts in excess of those budgeted; and

WHEREAS, the Wicomico County Sheriff's Office has received unanticipated revenue from the following sources: (1) Forfeiture of Funds by Circuit Court for Wicomico County- \$14,778; (2) State of Maryland (Sex Offender Monitoring)- \$31,400; and (3) Government of the District of Columbia-Metropolitan Police Department (Reimbursement for support at Presidential Inauguration)- \$45,336.95. The total unanticipated revenue is \$91,514.95; and

WHEREAS, the Sheriff's Office desires that said revenue be allocated among the various accounts specified below; and

WHEREAS, the Director of Finance has certified that the funds are available for appropriation.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland that the following appropriation of funds is authorized and approved:
