Introduced by: The President of the Council at the request of the County Executive

A RESOLUTION TO AUTHORIZE THE COUNTY EXECUTIVE TO ACQUIRE 3.5 ACRES OF LAND, MORE OR LESS, AND A 16-ACRE POND, LOCATED EAST OF MARDELA, KNOWN AS 9765 BARREN CREEK ROAD (TAX MAP 9, PARCEL 66), TO BE USED FOR THE RESTORATION OF BAREEN CREEK ROAD.

WHEREAS, pursuant to Section 22-1 of Chapter 22, entitled "County-owned property" paragraph A, the County Executive is authorized, on behalf of and in the name of Wicomico County, Maryland, to acquire by purchase, lease, exchange, gift or condemnation for public purpose any real property or interest therein in the County; and

WHEREAS, in July 2016, a section of Barren Creek Road was washed out during a severe rain event; and

WHEREAS, the land under and surrounding Barren Creek Road is owned by George M. Suggs, Jr. and Shirley J. Suggs, as shown in a Deed recorded among the Land Records of Wicomico County, Maryland in Liber 2894, Folio 158; and

WHEREAS, the County Executive desires to purchase the property owned by George M. Suggs, Jr. and Shirley J. Suggs, consisting of 3.5 acres of land, more or less, and a 16-acre pond, located east of Mardela, known as 9765 Barren Creek Road, to allow for the restoration of Barren Creek Road; and


WHEREAS, George M. Suggs, Jr. and Shirley J. Suggs have agreed to sell said property known as 9765 Barren Creek Road, Mardela Springs, MD for the purchase price of Two Hundred Ten Thousand Dollars (\$210,000).

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland that the County Executive be, and is hereby, authorized to acquire 3.5 acres of land, more or less, located on the east side of Mardela, known as 9765 Barren Creek Road, Mardela Springs, MD, (Tax Map 9, Parcel 66), at the purchase price of Two Hundred Ten Thousand Dollars (\$210,000), for the restoration of Barren Creek Road.
