A RESOLUTION AUTHORIZING THE COUNTY EXECUTIVE TO ACCEPT A CAPITAL PROJECT GRANT AWARD FROM THE STATE OF MARYLAND BOARD OF PUBLIC WORKS, WHICH IS TO BE ADMINISTERED BY THE MARYLAND DEPARTMENT OF GENERAL SERVICES, IN AN AMOUNT NOT TO EXCEED FIVE HUNDRED THOUSAND DOLLARS (\$500,000), TO BE USED FOR VARIOUS INFRASTRUCTURE IMPROVEMENTS TO THE ARTHUR PERDUE STADIUM.

WHEREAS, the Wicomico County Department of Recreation, Parks and Tourism completed a State of Maryland Capital Projects Grants Application titled "Arthur Perdue Stadium"; and

WHEREAS, the Maryland General Assembly has authorized a grant award to Wicomico County, in an amount not to exceed Five Hundred Thousand Dollars (\$500,000), for the Arthur Perdue Stadium Capital Project as provided in House Bill No. 151, DGS Item 150, Chapter 022, of the Laws of Maryland 2015; and

WHEREAS, the Maryland Capital Projects Grant award will be used for the planning, design, construction, repair, renovation, reconstruction and capital equipment of various infrastructure improvements to the Arthur Perdue Stadium; and

WHEREAS, the County Executive recommends the acceptance and appropriation of the grant award from the State of Maryland Board of Public Works.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland as follows:

1. The County Executive is hereby authorized to accept and appropriate a grant award from the Maryland Board of Public Works, which is to be administered by the Maryland Department of General Services, in an amount not to exceed Five Hundred Thousand Dollars (\$500,000).
2. The Arthur Perdue Stadium Capital Project Grant Award shall be applied to the Arthur Perdue Stadium Restoration/Modernization project number 15124 established within fund 32 (Account No. 02070060-520301-15124).
