A RESOLUTION AUTHORIZING J.G. PARKS & SON, INC. AS A SOLE SOURCE VENDOR FOR THE PURCHASE OF PROPRIETARY PARTS, SERVICE CALLS AND PREVENTATIVE MAINTENANCE ON FOR WESTERN STAR TRUCKS AND TO WAIVE THE FORMAL COMPETITIVE BIDDING PROCESS FOR THE PURCHASE OF SAID PROPRIETARY PARTS, SERVICE CALLS AND PREVENTATIVE MAINTENANCE DURING FISCAL YEAR 2018.

WHEREAS, pursuant to Charter Section 802 (A), any single purchase or contract involving an expenditure of more than Five Thousand Dollars (\$5,000) or such amount as may be set by legislative act of the county shall be made from or let by sealed bids or proposals; and

WHEREAS, on April 4, 2017, the County Council approved Legislative Bill 2017-04 enacting a new Purchasing Manual and setting the amount for competitive bidding to Twenty-Five Thousand Dollars (\$25,000); and

WHEREAS, pursuant to Charter Section 802 (B), the County Council may waive the formal competitive bidding process for any single purchase or contract if the waiver will best serve the interest of the County; and

WHEREAS, the Department of Public Works desires to purchase PROPRIETARY parts, service calls and preventative maintenance for Western Star Trucks that are crucial to the department's operations; and

WHEREAS, the County Executive, upon the recommendation from the Purchasing Agent, has determined that it is impractical to competitively bid the purchase of ~~these~~ parts, ~~service calls and preventative maintenance~~ as J.G. Parks & Son, Inc. is the only local authorized dealer ~~for sales and service~~ TO PURCHASE PROPRIETARY PARTS FOR Western Star Trucks; and

WHEREAS, the County Council has determined that the purchase of PROPRIETARY parts and repair service for Western Star Trucks is in the best interest of the County.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Wicomico County, Maryland as follows:


1. J.G. Parks & Son, Inc. is authorized as a sole source vendor for the purchase of PROPRIETARY parts, service calls and preventative maintenance for Western Star Trucks during Fiscal Year 2018.
2. The formal competitive bidding requirement is hereby waived for the purchase of PROPRIETARY parts, service calls and preventative maintenance for Western Star Trucks during Fiscal Year 2018.

3. To ensure a transparent environment that is open and fair, the approval of J.G. Parks & Son, Inc. as a sole source vendor and the waiver for competitive bidding shall be valid only for a period of one year, commencing July 1, 2017 and ending June 30, 2018.
