### Resolution No. 08-2020 (SM)

Introduced by: The President of the Council at the request of the County Executive

A RESOLUTION AUTHORIZING AD MEYERS UNIFORMS, LLC AS A SOLE SOURCE VENDOR FOR THE PURCHASE OF UNIFORMS FOR THE SHERIFF'S OFFICE AND TO WAIVE THE FORMAL COMPETITIVE BIDDING PROCESS FOR THE PURCHASE OF SAID UNIFORMS DURING FISCAL YEAR 2020.

WHEREAS, pursuant to Charter Section 802 (A), any single purchase or contract involving an expenditure of more than Five Thousand Dollars (\$5,000) or such amount as may be set by legislative act of the county shall be made from or let by sealed bids or proposals; and

WHEREAS, on April 4, 2017, the County Council approved Legislative Bill 2017-04 enacting a new Purchasing Manual and setting the amount for competitive bidding to Twenty-Five Thousand Dollars (\$25,000); and

WHEREAS, pursuant to Charter Section 802 (B), the County Council may waive the formal competitive bidding process for any single purchase or contract if the waiver will best serve the interest of the County; and

WHEREAS, the Wicomico County Sheriff's Office desires to purchase uniforms that have the same fabric and colors currently used by the Sheriff's Office; and

WHEREAS, the County Executive, upon the recommendation from the Purchasing Agent, has determined that it is impractical to competitively bid the purchase of said uniforms as AD Meyers Uniforms LLC is the sole manufacturer and distributor of the uniforms that have the same fabric and colors currently used by the Sheriff's Office; and

WHEREAS, the County Council has determined that the purchase of the uniforms is in the best interest of the County.


NOW, THEREFORE, BE IT RESOLVED by the County Council of Wicomico County, Maryland as follows:

1. AD Meyers Uniforms, LLC is authorized as a sole source vendor for the purchase of uniforms for the Sheriff's Office during Fiscal Year 2020.
2. The formal competitive bidding requirement is hereby waived for the purchase of uniforms for the Sheriff's Office during Fiscal Year 2019.
3. To ensure a transparent environment that is open and fair, the approval of AD Myers Uniforms, LLC as a sole source vendor and the waiver for competitive bidding shall be valid only during fiscal year 2020 (July 1, 2019-June 30, 2020).


