Introduced by: The President of the Council at the request of the County Executive

A RESOLUTION TO MAKE AN APPROPRIATION OF FUNDS TO THE SHERIFF'S OFFICE FROM UNANTICIPATED REVENUE IN THE AMOUNT OF ONE HUNDRED TWENTY-FOUR THOUSAND, SEVENTY-FIVE DOLLARS AND TWENTY-ONE CENTS (\$124,075.21).

WHEREAS, Section 709 of the Wicomico County Charter authorizes and empowers the Wicomico County Council, upon the request of the County Executive, to make appropriations from revenue receipts in excess of those budgeted; and

WHEREAS, the Sheriff's Office for Wicomico County has received unanticipated revenue from the following sources: (1) Confiscated/Forfeited Funds-\$45,284.65 (2) State of Maryland (Sex Offender Monitoring Initiative)-\$37,000; (2) Pete Richardson Auction Sales (Sale of Property/Equipment)-\$18,251.25; (3) Local Government Insurance Trust (total loss of vehicle)-\$455; (4) Sussex Scrap Meter (Recycle of Old Batteries, Sheet Iron)-\$38.80; (5) GovDeals Inc. (Sale of Seized/Forfeited Property)-\$20,295.51; and (6) Weapon Buy Back Program-\$2,750.00; and

WHEREAS, the Sheriff's Office desires that said revenue be allocated among the accounts specified below; and

WHEREAS, the Director of Finance has certified that the funds are available for appropriation.

NOW, THEREFORE, BE IT RESOLVED, by the Wicomico County Council that the following appropriations of funds are authorized and approved:




