RESOLUTION NO. 53-2020

Introduced by: The President of the Council at the request of the County Executive

A RESOLUTION AUTHORIZING THE COUNTY EXECUTIVE TO ACCEPT A GRANT AWARD, IN THE AMOUNT OF \$180,000, FROM THE MARYLAND STATE DEPARTMENT OF EDUCATION, DIVISION OF EARLY CHILDHOOD.

WHEREAS, the Early Childhood Division of the Maryland State Department of Education is responsible for early care and education in Maryland so that young children are well prepared for school; and

WHEREAS, the Maryland State Department of Education, through the Early Childhood Division, has awarded the Wicomico County Local Management Board grant funds in the amount of \$180,000; and

WHEREAS, the grants funds will be used to provide the following: (1) Behavior Attachment Therapy, (2) 45 hours Infant and Toddler Course, (3) Parent Infant Education training, (4) Mental Health and Wellness Infant and Toddler Manipulatives, (5) Part-time reimbursement for coordinators at the the main braches of the Tri-County libraries to help coordinate mental health pieces for telehealth, and (6) Promoting Positive Outcomes resource fair at the Wicomico Youth and Civic Center; and

WHEREAS, the Council understands that the County Executive has reviewed carefully the entire award document and has notified or will promptly notify all key staff about the award requirements; and

WHEREAS, Chapter 29, Article II (Grant Funds) of the Wicomico County Code prescribes in subsection 29-20.B the procedure by which the County Council may by resolution appropriate “unanticipated grant revenue” from grants not included in the Annual Budget and Appropriation Bill; and

WHEREAS, the grant award does not require an appropriation of local matching funds; and

WHEREAS, the County Executive recommends acceptance of the grant award, in the amount of \$180,000, from the Maryland State Department of Education, Early Childhood Division.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland, that the County Executive is hereby authorized to accept a grant award, in the amount of \$180,000, from the Maryland State Department of Education through the Early Childhood Division for the purposes stated above.

NOW, THEREFORE, BE IT FURTHER RESOLVED, by the County Council of Wicomico County, Maryland, as follows:


1. The Wicomico County Local Management Board shall administer the expenditure of the grant funds.
2. This resolution and the action taken by Council herein are subject to proper compliance with the conditions specified Chapter 29, Article II, titled "Grant Funds" of the County Code, following the passage of this resolution.
3. The aforementioned grant from the Maryland State Department of Education to the Local Management Board does not require an appropriation of local matching funds and, therefore, does not require certification by the Director of Finance to the County Council.
4. This resolution does not establish or authorize any County employee position.
