RESOLUTION NO. 96-2020

Introduced by: The President of the Council at the request of the Acting County Executive

A RESOLUTION RECOMMENDING THE APPROVAL FOR THE SALE OF A LAND PRESERVATION EASEMENT FROM MARVIC ASSOCIATES, LLC.

WHEREAS, the County Council has determined that it is in the public's interest to preserve agricultural acres to conserve farmland for future food and fiber production; ensure continued high-quality food supply for our citizens; and, preserve the agricultural industry and rural communities; and

WHEREAS, a landowner in Wicomico County who is interested in protecting his/her/its land from development by preserving it for agricultural purposes and/or is interested in preserving the woodlands on his/her/its property in Maryland's Agricultural Land Preservation Program, may submit an application for the sale of a Land Preservation Easement to the Maryland Agricultural Preservation Foundation; and

WHEREAS, MARVIC Associates, LLC has submitted an application for the sale of a Land Preservation Easement to the Maryland Agricultural Preservation Foundation, which has been reviewed by the Wicomico County Planning Commission and the Agricultural Land Preservation Advisory Board; and

WHEREAS, the Wicomico County Planning Commission and the Agricultural Land Preservation Advisory Board have determined that the sale is compatible with existing and approved County plans and overall County policy, and have recommended the sale of the easement; and


WHEREAS, the County Council has held a public hearing, following due notice, and determined that a recommendation for the sale of a Land Preservation Easement is appropriate.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland, that the sale of a Land Preservation Easement from MARVIC Associates, LLC to the Maryland Agricultural Preservation Foundation is recommended for approval, containing the following described land:

Property located Southwest of Powellville on both sides of Laws Road on Map 60, Parcels 17 and 19, Grid 5 and 12 consisting of 167.29 acres, all as described in a deed recorded among the Land Records of Wicomico County, Maryland, in Liber M.S.B. 4253, Folio 1; and known as Laws Road, Parsonsburg, Maryland; Tax ID Nos. 06-002412 and 06-002404.


