RESOLUTION NO. 174-2020

Introduced by: The President of the Council at the request of the Acting County Executive

A RESOLUTION AUTHORIZING THE ACTING COUNTY EXECUTIVE TO ACCEPT A GRANT AWARD FROM THE MARYLAND DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT IN AN AMOUNT UP TO \$115,000.00 FOR CITIZENS NEEDING EMERGENCY RENTAL ASSISTANCE.

WHEREAS, the Maryland Department of Housing and Community Development has awarded the Wicomico County Department of Planning, Zoning and Community Development Coronavirus Relief grant funds in an amount up to \$115,000.00 to provide immediate help for citizens needing emergency rental assistance; and

WHEREAS, Wicomico County agrees to use the grant funding in compliance with the Maryland Department of Housing and Community Development requirements, and the laws of the State of Maryland and the United States; and

WHEREAS, the Council understands that the Acting County Executive has carefully reviewed the entire award document and has notified or will promptly notify all key staff about the award requirements; and

WHEREAS, the grant award does not require an appropriation of local matching funds; and

WHEREAS, the Acting County Executive recommends the acceptance of the Maryland Department of Housing and Community Development Grant in an amount up to \$115,000.00.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Wicomico County, Maryland, as follows:

1. The Wicomico County Department of Planning, Zoning and Community Development shall administer the expenditure of the Grant funds for emergency rental assistance. The three subrecipients and funding amounts are as follows:
 - (a) Salisbury Neighborhood Housing Services, Inc. - \$45,000.00;
 - (b) Wicomico County Local Management Board - \$20,000.00; and
 - (c) Habitat for Humanity of Wicomico County - \$50,000.00.
2. This Resolution and the action taken by Council here are subject to proper compliance with the conditions specified in Chapter 29, Article II, titled "Grant Funds" of the County Code, following the passage of this Resolution.
3. The Acting County Executive is authorized to accept and appropriate the aforementioned grant from the Maryland Department of Housing and Community

Development in an amount up to \$115,000.00 in accordance with the Maryland Department of Community Development requirements, and the laws of the State of Maryland and the United States.

4. This Resolution does not establish or authorize any County employee position.
