WICOMICO COUNTY LIQUOR LICENSE DEPARTMENT

BEER / WINE TASTING LICENSE
CLASS "A" BEER, BEER & WINE OR BEER, WINE AND LIQUOR LICENSE

- A Wine Tasting and / or Beer Tasting License Can **Only** Be Issued To A Class "A" Beer, Beer & Wine or Beer, Wine and Liquor Off Sale License.
- Then Annual Fee is
 - Beer or Wine \$ 150.00
 - Beer and Wine \$ 250.00
- Application shall be made on forms supplied by the Wicomico County Liquor License Department Renewals may be made at the time the regular license is renewed. A license may be granted without a public hearing; however, if the application is denied, the applicant may request a public hearing before Wicomico County Board of Commissioners.
- A maximum of SIX (6) bottles of Wine or Six (6) bottles of Beer may be opened at any one time.
- The Wine Tasting Licensee may not serve to any person for sampling or tasting purposes more than one (1) ounce from each brand.
- The Beer Tasting License may not serve to any person for sampling or tasting purpose more than one (3) ounce from each brand.
- A Wine and / or Beer Sampling or Tasting event may not be held more than 20 days each licensing period. (May 1st thru April 30th)
- The licensee shall notify the Wicomico Liquor Licensing Department in Writing at least 5 Business days prior to each event.
- Once opened, the bottle used for the wine and / or sampling or tasting event shall be marked that it is to be used for that purpose only.
- The contents of each bottle may not be mixed with any other bottle and all bottles shall be destroyed once they are empty.
- The Wine and / or Beer Tasting Licensee must comply with any regulations as required by the Health Department and Zoning Department.
- Wine and / or Beer Tasting Licensee and / or employees and / or promoters shall not furnish wine for the purposes of a wine / beer sampling or tasting event to any person who is under 21 years of age.

- Wine / Beer Tasting Licensees shall not furnish wine and /or Beer for the purposes of wine / beer sampling or tasting event to any person who is visibly under the influence of alcoholic beverages at the time of such dispensing.
- A Wine / Beer Tasting License are for on-premises consumption only. An open container may not be carried from the premises to be consumed elsewhere.
- Wine / Beer sampling or tasting may not be conducted from a drive-through window.
