Introduced: August 2, 2011

BY: The Council President at the request of the County Executive.

AN ACT to reorganize functions among the Department of Public Works and the Department of Planning, Zoning and Community Development; and to shift the function of risk management from Human Resources to ~~the Executive Office under~~ the Purchasing Agent.

PREAMBLE

Section 504 of the Wicomico County Charter provides that when the County Executive deems substantial reorganization within the executive branch to be in the best interest of efficient government, he shall prepare a reorganization plan which shall be introduced in the form of a bill.

The County Executive has determined that greater efficiencies may be achieved by combining similar services within and between the Departments of Public Works, Planning, Zoning & Community Development and by shifting the function of risk management from Human Resources to ~~the Executive administrative office under~~ the Purchasing Agent.

SECTION I. BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that the designated functions, services and positions be transferred and reorganized as follows:


- A. The “development division” of the Department of Public Works, including development review, addressing, and inspection, located within the Government Office building, shall be transferred to the Department of Planning, Zoning and Community Development. The reorganization will be as shown on the attached Exhibit 1.
- B. The Department of Public Works shall consist of the remaining divisions of Roads and Solid Waste. The organization will be as shown on the attached Exhibit 2.
- C. The risk management function shall be transferred to ~~the Executive administrative office under~~ the supervision of the Purchasing Agent. The reorganization will be as shown on the attached Exhibit 3.


SECTION II. Be it Further Enacted, that this Bill shall not be codified in the Wicomico County Code.

SECTION III. Be It Further Enacted, that this Bill shall be known as Bill No. 2011-08 of Wicomico County, Maryland and shall take effect, SUBJECT TO THE ADOPTION OF LEGISLATIVE BILL 2011-11, sixty (60) days after its enactment, unless a proper Petition for Referendum thereof shall be filed prior to said date; in which event, the Bill shall not take effect until the expiration of thirty (30) days following the approval of this Bill by a majority of the qualified voters of the County voting in any such referendum.




