AN ACT to temporarily amend Chapter 200, titled "Subdivision of Land" to extend for a period of ~~two~~ FIVE years the approvals and deadlines for certain permits issued by Wicomico County for development projects; ~~and to authorize the County Council of Wicomico County to extend the approvals and deadlines for said permits for an additional one year period, by Resolution.~~

## PREAMBLE

WHEREAS, various segments of the economy, such as banking, real estate and construction, have been impacted significantly by the national recession; and

WHEREAS, as a result of the economic crisis, real estate developers, homebuilders, and commercial, office and industrial developers have experienced an industry-wide decline; and

WHEREAS, the process to obtain Planning Commission approvals for development projects, including but not limited to, preliminary and final subdivision plans can be difficult, time consuming, and expensive both for applicants and government entities; and

WHEREAS, Legislative Bill 2011-12, adopted January 3, 2012, extended approvals and deadlines for certain permits issued by Wicomico County for development project for a period of two years, beginning January 1, 2012 and ending December 31, 2013; and

WHEREAS, existing permits, approvals and deadlines are and will be expiring or lapsing simply due to the passage of time; and

WHEREAS, the construction industry and related trades are sustaining severe economic losses, and the lapsing of development approvals would, if not addressed, exacerbate those losses; and

WHEREAS, Financial institutions that lend money to property owners, builders, and developers are experiencing erosion of their collateral as permits and approvals expire, and the extension of these permits and approvals is necessary to maintain the value of the collateral; and

WHEREAS, based on the above, the County Council finds and declares that further extending certain development approval periods and deadlines is required and is in the best interest of the citizens of Wicomico County and will preserve and improve the health, safety and general welfare of Wicomico County.

**SECTION I.** BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, as follows:

Definitions.

In this Bill, unless the context indicates otherwise, all terms shall have the same meaning as provided in the Wicomico County Code.

Approvals.

This Bill temporarily modifies the application of certain provisions of the Wicomico County Code, including Chapter 200 Sections 200-7, 200-8 and 200-10, to extend, for ~~two~~ FIVE years, the approval periods and deadlines for the following (collectively hereinafter referred to as "Approvals") beginning January 1, 2014 and ending December 31, ~~2015~~ 2018. ~~The County Council of Wicomico County is authorized to further extend the approval period and deadlines for an additional one year, ending December 31, 2016, by Resolution.~~

- Preliminary Plat Approvals
- Final Plat Approvals
- Phased Approvals
- Record Plat

Applicability.

- A. This Bill shall apply and extend those approvals, described above, which were active and valid as of the effective date of this Bill. This Bill shall not apply to Approvals that may be granted or become effective after the effective date of this Bill.
- B. This Bill does not apply to
1. Any permit or approval that has an expiration date established under a law or regulation of the State of Maryland; or
  2. Any permit, license or approval issued under Title 4, Subtitle 1 or Subtitle 2, Title 5, Subtitle 5, or Title 9 of the Environment Article of the Annotated Code of Maryland.

Codification Unnecessary.


Due to the self-limiting nature of this Bill, it will not be codified in the Wicomico


County Code but shall have the full force and effect of law as if published in the Wicomico County Code.

**SECTION II.** BE IT FURTHER ENACTED THAT this Bill shall be known as Bill No. 2013-06 of Wicomico County, Maryland and shall take effect sixty (60) days after its final passage, unless a proper Petition for Referendum thereof shall be filed prior to said date; in which event, the Bill shall not take effect until the expiration of thirty (30) days following the approval of this Bill by a majority of the qualified voters of the County voting in any such referendum.


