**AN ACT** to amend the Wicomico County Classification and Pay Plan by reinserting a job classification in the Department of Law and reestablishing a class title and grade.

PREAMBLE

The Wicomico County Classification and Pay Plan provides a system of standardized title and common job language critical to the effective administration of County personnel.

The County Executive, at the request of the County Attorney, recommends the reestablishment of the "Assistant County Attorney" position within the Department of Law to ensure adequacy of staffing in the department and for the continuity of operations for the foreseeable future.

**SECTION I.** BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that the Wicomico County Classification and Pay Plan is hereby amended as follows:

The following specified job classification and grade is hereby reestablished:

Department of Law

<u>Classification</u>	<u>Grade</u>
Assistant County Attorney	20


**SECTION II.** Be it Further Enacted, that this Bill shall not be codified in the Wicomico County Code.

**SECTION III.** Be It Further Enacted, that this Bill shall be known as Bill No. 2013-11 of Wicomico County, Maryland and shall take effect sixty (60) days after its enactment, unless a proper Petition for Referendum thereof shall be filed prior to said date; in which event, the Bill shall not take effect until the expiration of thirty (30) days following the approval of this Bill by a majority of the qualified voters of the County voting in any such referendum.


