Introduced: June 16, 2015

BY: The Council President at the request of the County Executive.

AN ACT to reorganize General Services under the direction and control of the Department of Public Works, in accordance with the County Executive's budget message and to transfer the function of the Government Office Building security employees to the Department of Human Resources.

WHEREAS, Wicomico County Charter section 503B states, "New divisions of existing offices and departments shall not be created except by legislative act proposed by the County Executive and passed by the County Council."; and

WHEREAS, General Services is responsible for the maintenance of a portion of the County facilities, as well as the copier and mail room operations in the Government Office Building, and has operated as its own division of the County Executive's Office and has a separate budget as if it was a department; and

WHEREAS, the County Executive deems it appropriate for General Services to be a division of Public Works and better suited to be supervised and managed by the Department of Public Works; and

WHEREAS, the Government Office Building security employees are charged with maintaining security for all employees and visitors of the building; and

WHEREAS, building security has not been a function of the Department of Human Resources, the County Executive deems that the Government Office Building security employees are better suited to be supervised and managed by the Department of Human Resources as a new division of that department; and

WHEREAS, it appears advisable, upon the favorable recommendation of the County Executive that the General Services division be transferred to the Department of Public Works and that the Government Office Building security employees be transferred to the Department of Human Resources.

SECTION I. BE IT FURTHER ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION that this Bill shall not be codified in the Wicomico County Code.

SECTION II. BE IT FURTHER ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION that this Bill shall be known as Bill No. 2015-06 of Wicomico County, Maryland and shall take effect subject to the adoption of Legislative Bill 2015-03, sixty (60) days after its enactment, unless a proper Petition for Referendum thereof shall be filed prior to said date; in which event, the Bill shall not take effect until the expiration of thirty (30) days following the approval of this Bill by a majority of the qualified voters of the County voting in any such referendum.




