Introduced: July 5, 2016

BY: The Council President at the request of the County Executive and the Department of Public Works.

AN ACT to amend Chapter 156 of the Wicomico County Code, titled "Garbage, Rubbish and Refuse" Article II, titled "Household Refuse Permits," Section 156-8, titled "Issuance of permit."

WHEREAS, The Department of Public Works deems it advisable to issue Household Refuse Permits that are valid for one year from the date of issuance.

WHEREAS, it appears advisable, upon the favorable recommendation of the County Executive and the Department of Public Works, to amend Chapter 156 of the Wicomico County Code, titled "Garbage, Rubbish and Refuse", Article II, titled "Household Refuse Permits", Section 156-8, titled "Issuance of Permit" to issue Household Refuse Permits that are valid for one year from the date of issuance.

SECTION I: BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that Chapter 156 of the Wicomico County Code, titled "Garbage, Rubbish and Refuse," Article II, titled "Household Refuse Permits," Section 156-8, titled "Issuance of Permit" be and the same is hereby amended, to read as follows:

CHAPTER 156
GARBAGE, RUBBISH AND REFUSE

* * *

Article II
Household Refuse Permits

§156-8 Issuance of permit.


- A. The Director of the Department of Public Works shall examine or cause to be examined all applications for permits within a reasonable time after filing. If the application does not conform to the requirements of all pertinent laws, he shall reject such application in writing, stating the reasons therefor. If he is satisfied that the application conforms to the requirements of this Code and all laws and ordinances applicable thereto, he shall issue a permit as soon as practicable.

B. ~~Permits shall be issued for a period of one year commencing on July 1 and expiring on the succeeding June 30.~~ PERMITS SHALL BE VALID FOR A PERIOD OF ONE YEAR FROM THE DATE OF ISSUANCE.

SECTION II. BE IT FURTHER ENACTED THAT this Bill shall be known as Bill No. 2016-07 of Wicomico County, Maryland and shall take effect sixty (60) days after its final passage, unless a proper Petition for Referendum thereof shall be filed prior to said date; in which event, the Bill shall not take effect until the expiration of thirty (30) days following the approval of this Bill by a majority of the qualified voters of the County voting in any such referendum.


