AN ACT to amend the Wicomico County Classification and Pay Plan by the addition and deletion of certain job classifications in the Sheriff's Office and establishing certain class titles and grades.

PREAMBLE

The Wicomico County Classification and Pay Plan provides a system of standardized title and common job language critical to the effective administration of County personnel.

The County Executive, at the request of the Wicomico County Sheriff, recommends the abolishment of two positions and the establishment of two Deputy Sheriff/First Sergeant positions to allow for succession planning and continuity of operations.

SECTION I. BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that the Wicomico County Classification and Pay Plan is hereby amended as follows:

A. The following specified job classifications and grades are hereby added:

Wicomico County Sheriff's Office

<u>Classification</u>	<u>Grade</u>
Deputy Sheriff/First Sergeant	1SG
Deputy Sheriff/First Sergeant	1SG

B. The following specified job classifications and grades are hereby deleted:

Wicomico County Sheriff's Office



Deputy Sheriff/Corporal	CORP


SECTION II. Be it Further Enacted, that this Bill shall not be codified in the Wicomico County Code.

SECTION III. Be It Further Enacted, that this Bill shall be known as Bill No. 2016-09 of Wicomico County, Maryland and shall take effect sixty (60) days after its enactment, unless a proper Petition for Referendum thereof shall be filed prior to said date; in which event, the Bill shall not take effect until the expiration of thirty (30) days following the approval of this Bill by a majority of the qualified voters of the County voting in any such referendum.






